Corporator says MMRDA was set to build skywalk in Vile Parle (East); **MMRDA** has no such plan

If you thought that carrying out a signature campaign would stop the construction of an unwanted public utility, think again. The Shiv Sena's recent actions show that it can even halt projects that haven't been planned in the

Local Sena workers, along with corporator Shashikant Patkar, recently carried out a signature campaign against a proposed skywalk that is to come up on the eastern side of Vile Parle station. But, according to officials of the Mumbai Metropolitan Region Development Authority (MMRDA), which is building skywalks throughout the region, no such walkway has been

The MMRDA is in the process of con-

structing as many as 60 skywalks throughout the Mumbai metropolitan region. A pedestrian overground link is already under construction in Vile Parle (West).

About a fortnight ago, Sena workers started a campaign to stop construction of the skywalk. Patkar claimed that the pathway would start from Mongibhai Road and connect Nehru Road

"We got to know that the MMRDA

was planning to build a skywalk in this area," said Patkar. "Officials had finished their survey and were about to begin construction. Our party workers had to throw out the labourers from

"Hence we decided to carry out a signature campaign. We managed to get as many as 15,000 people to support us. The verdict is clear; we don't want a skywalk in this area.'

VERSOVA MAID CONSUMES PHENYL

A housemaid allegedly consumed phenyl after a heated argument with her employer. Shilpa Punjabi, a resident of Bhaktiyani Apartment at Yari Road, lodged a complaint with the police on Monday accusing her maids Sushma Sudhakar, 19 and Nandini Polwal, 18, of stealing Rs12.39 lakh from her safe with the help of duplicate keys. When Punjabi confronted the maids, they had a heated argument. In a fit of anger, Polwal gulped down a small amount of Phenyl. She was admitted to Cooper Hospital and is said to be out of danger. "We have found some money from the houses of the maids. We are investigating the case," said senior inspector S Nalavde.

WOMAN FOUND DEAD IN VAKOLA

A 55-year-old woman was found dead in her residence in Sai Baba Rahiyasi Sangh. Vakola, on Thursday. According to the police, Mansi Prabhakar Mahadik, the deceased, was found lying in a pool of blood by a neighbour when she visited her house around 5.30 pm. The neighbour immediately informed the family members about the incident. Mahadik lived with her daughter, son and daughter-in-law. The incident took place when she was alone at home. "We have registered a murder case. The investigation is under way. There are no reports of cash or jewellery missing from the houSe," said Arvind Mahabadi, assistant commissioner of police, Vakola division.

After marathon, city may see cycle-a-thon

BMC plans to set up dedicated tracks to encourage bicycling **Sandeep Ashar**

In a bid to promote the bicycle culture in Mumbai, the Brihanmumbai Mumbai Corporation (BMC) is flirting with the idea of

organising a cycle-a-thon on the lines of the Mumbai Marathon. The idea, which is still at a nascent stage, is already being appreciated. Film actor Rahul Bose

is among those promoting it. The corporation has already begun drawing up plans to set up dedicated bicycle tracks for short-distance travel in several parts of the city. Additional municipal commissioner RA Rajeev said the BMC was in the process of finalising a consultant for studying the concept and identifying neighbourhoods where tracks could be laid.

With growing traffic conges tion and a rise in pollution, citi zens' groups in areas like Mal-abar Hill, Bandra Bandstand, Carter Road, Irla, Lokhandwala Complex, and Mulund have been demanding dedicated bicycle lanes. In fact, enthusiasts, students, and parents from 15 schools in Mulund have demanded dedicated lanes and parking space for bicycles on each road in the city.

The Mulund Parents' Association has even initiated an eco-club which promotes cycle rides, "It is a matter of great astonishment that one prefers a luxurious car

drive at the cost of polluting the environment. We feel awkward riding a bicycle, which is a better mode of transport for short distances," said Yogesh Katira, presdent of the association.

Katira blamed the wrong policies of the state government for the disappearance of bicycles. 'The road development policies have been car-centric," he said.

Metro-II contract in legal tangle

Medha Patkar's NGO files complaint with ACB

Ghar Bachao Andolan, a city-based nongovernment organisation (NGO) mentored by social activist Medha Patkar. has filed a complainant with the Anti-Corruption Bureau (ACB) against the awarding of the contract to Reliance Infrastructure for the second phase of Metro in the city. However, according to

ACB sources, no FIR has been registered. The complaint has named officials of the state government as well as the

Mumbai Metropolitan Region Development Authority (MMRDA) as accused. It states that the contract awarding the work to Reliance Infrastructure has many violations. "It violates the Indian Tramways Act

1886, since there is no mention of the route which is going to be used as a tramway. Besides, no change has been done in the contract after suggestions and objections received by MMRDA. The bhoomipujan was carried out without any prior environmental clearances," said the letter written by Simpreet Singh and HM Chandrashekhar, members of the NGO.

BMC's notice to Wankhede contractor

The BMC has objected to an "illegal" Cricket Association's Wankhede Stadium, which is being renovated for the 2011 World Cup final.

A senior civic official said a notice had been sent to Larsen & Toubro, which has been appointed contractors by the MCA. The MCA has also been given a copy of the notice.

The Marine Drive Residents' Association had complained that unhygienic conditions in the labourers' colony inside the stadium were responsible for the spread of malaria in the area.

During an inspection drive carried out by the BMC, the inspectors found that the temporary structures did not have the requisite permissions.]

Assistant municipal commissioner Sunil Dhamane said cases of malaria continue to be reported from buildings in and around the stadium. Despite several attempts, MCA officials were unavailable for comment.

The under-construction station building on the eastern side of Andheri station is likely to be operational in April next year. The three-storey structure will have all kinds of passenger amenities — ticket booking offices, reservation counters, waiting rooms, food plazas, toilets, lifts, etc. "Once the new building is in place, the old one on the western side of the station will be demolished," said a Western Railway (WR) official.

The new building will measure 2,924 sq m — its ground floor spreading over 1,130 sq-m, and the first and the second floors measuring 897sq-m each. Construction work began on November 10. "The ground and the first floors, which will have seven counters for outstation
